

## Application to suspend the transport of property-specific waste

At the initiative of the occupant of the property or their representative, the transport of property-specific waste may be suspended for a fixed period of time if the property is unused. A suspension lasting less than six months can be agreed directly with Etelä-Karjalan Jätehuolto Oy (notice of the suspension must be submitted no later than one week before the suspension begins). If the interval between the dry waste container emptying is 12 or 16 weeks, a suspension shorter than six months is not possible.

In the event of a suspension of waste transport lasting longer than six consecutive months, a deviation permit must be applied for from the waste management authority. Application for the suspension of waste transport must be submitted no later than one month before the start of the desired suspension.

The property should not be used for housing during the suspension of property-specific waste transport. The suspension does not eliminate the annual fees payable for the property either (basic fee, official fee, and possible municipal surcharge).
